Instructions on How to Obtain a Money247 Account & Card

Step 1: Provide Personal Details to Money247 Agent.

- ID Number
- Name & Surname
- Date of Birth
- Address
- Cell Number
- Beneficiary Details
- Signed Application Form

Step 2: Receive an SMS from Money247 that your Account has been Registered.

Your personal username and password will be SMS'd to you by M247. You can then access your account via the internet by using this info at www.money247.co.za. You will be asked to change your password when you enter the M247 website for the first time.

Important Note: Your Cell Number is also your Account Number.

Step 3: Deposit R150 into your Money247 Account.

You will then receive an SMS from M247 with instructions where to pay in the R150 registration fee. This amount must then be deposited into your Money247 Account at any of the mentioned “PAY @” Service Centres or you can make payment via EFT.



Step 4: Provide Proof of Deposit and FICA to the Money247 Agent.

Ensure you obtain proof from the “PAY @” store or when performing an EFT when making the deposit. Ensure you have your ID Book/Passport/Asylum Document as well as your Proof of Address (Less than 3 months old) with you when providing the proof to the Money 247 Agent.

Step 5: Receive your Money247 Card from the Money247 Agent.

The Money247 Agent will then allocate a Master Card to you upon receipt of the above documentation (Step 4). You will receive an SMS from Money247 that your Card has been activated. The Card together with the following information will be contained in the envelope handed to you by the agent:

- Card Pin.
- A welcome letter with relevant contact information and security tips.
- Letter to your employer indicating how to deposit your salary into your Money247 account.
- Full details of Terms & Conditions for the Money247 Protection Plan.

Important Note: You would need to indicate to the agent the % of deposited amounts to be auto loaded on your card. This feature is available to minimize losses due to ATM theft.
